

RULES AND REGULATIONS

The Little Miss & Young Miss South Dakota International Pageants are designed to give young ladies a positive environment to express themselves. Judges will be looking for community involvement, personality, etiquette, poise and beauty. This is a natural pageant. **Make up, faux hair & faux teeth are NOT permitted.** The only make up allowed is black mascara and clear lip gloss. The competitions will be presented with organized interview, onstage introduction and party dress. There will be a winner in the Little Miss and Young Miss divisions. Each new titleholder will receive an official crown and sash.

No previous pageant experience required.

TO QUALIFY A CONTESTANT MUST MEET THE FOLLOWING REQUIREMENTS:

1. *You must be at least 5 years old by 10/1/24 and not older than 9 years old on 7/1/25. 2. Must be of good health and moral character. 3. A U.S. citizen and a resident of South Dakota for at least six months as of competition date. 4. Each contestant will be subject to an entry fee. 5. You must submit a copy of your official birth certificate with your application and fee. 6. You agree that the judges' decision is final. 7. Any contestant, family member or guest showing less than sportsman-like behavior will lead to disqualification of the contestant. 8. If selected, you agree to abide by all rules and regulations of the state and/or forfeit the title. If a contestant relinquishes her title, for any reason, all prizes must be returned in full, and in condition received. This includes the official crown and sash. _____(Initial here) 9. You will permit The South Dakota International Pageants L.L.C. and their licensees the right to use your photograph for publicity purposes in connection with The South Dakota International Pageants. 10. You will permit The South Dakota International Pageants L.L.C. and their licensees to televise

live or by use of film or videotape any portion or all of the competition. 11. All titleholder appearances, media, interviews, printed materials need the approval of the state director in advance of making a commitment to appear. 12. Any misrepresentation of information on this application will result in disqualification.

This is the responsibility of the contestant.** A complete packet of information will be emailed to you after your application and payment are received closer to the pageant date. There is no talent/performance competition in this pageant. All fees paid are non-refundable.
